

West Whitlawburn Housing Co-operative's Annual Performance Report on The Scottish Social Housing Charter

Each year the Co-operative is required to report to the Scottish Housing Regulator on how we performed over a number of areas and compare this to the Scottish average.

Out of the 13 indicators reported 10 were above the Scottish average and only 3 slightly below the Scottish average. This is a huge achievement and this report details the breakdown of each indicator.



Report to tenants 2018/19

Tenant satisfaction

Of the tenants who responded to our most recent tenant satisfaction survey:

93.4%

said they were satisfied with the overall service we provided.

Scottish average 90.1%.

94.2%

felt that we were good at keeping them informed about our services and outcomes.

Scottish average 91.6%.

83.5[%]

of tenants were satisfied with the opportunities to participate in our decision making process.

Scottish average 86.5%.

Quality and maintenance of homes

98.9%

of our homes met the Scottish Housing Quality Standard.

The average time we took to complete emergency repairs was 3.7 hours.

For every 100 of our homes, 17.1 cases of anti-social behaviour were reported in the last year.

90% of these cases were resolved within targets agreed locally.


