

Register of Interests

West Whitlawburn Housing Co-operative (WWHC) has a range of governance policies, processes and systems in place covering the declaration and management of interests such as:

- Entitlements, Payments and Benefits Policy.
- Declarations of Interest Policy.
- Codes of Conduct for Committee and Staff.

It is a requirement for Committee and Staff to declare any interests that they may have that may have any bearing on WWHC's business.

Each year (or when there are any changes) Committee and Staff are required to declare any such interests which are then entered into our Register of Interests.

Where an interest is declared, the Committee Member in question does not take part in the section of the Committee meeting dealing with the matter. Where a staff member has declared an interest, appropriate management arrangements are put in place to manage a potential conflict.

As a fully mutual co-operative, all Committee Members are tenants or prospective tenants, unless they are a co-opted non-member. Some committee members and staff have family members who are also tenants.
